## Total Ready Mix Concrete & CLSM Production Dues:

<u>Annual Volume (cu yds)</u>	<u>2010 Annual Dues</u>
0 - 20,000	\$775 plus \$0.05 per yard on volume above 10,000 cubic yards
20,000 - 100,000	\$1250 plus \$0.045 per yard on volume above 20,000 cubic yards
100,000 - 200,000	\$5,750 plus \$0.035 per yard on volume above 100,000 cubic yards
200,000 - 400,000	\$10,130 plus \$0.03 per yard on volume above 200,000 cubic yards
> 400,000	\$17,650 plus \$0.02 per yard on volume above 400,000 cubic yards

Note: Maximum Dues are \$25,790 for Ready Mix Concrete

## Combination Production Dues:

Companies producing both ready mix and aggregate pay according to both the ready mix and aggregate production schedules. The cap of maximum payment to ARM for any company with combined ready mix and aggregate productions is the total maximum dues for ready mix concrete (\$25,790) and aggregate production (\$5,350) for a maximum of \$31,140.
